We hereby confirm that our semi-finished products made of

SUSTASON PPSU MG natural (NT15), black (BK937), grey (GY1037)

Polyphenylsulfone (PPSU – ISO 1043) is compliant with applicable FDA regulations for food contact. These products are extruded by using raw material (polymer and colorants), that is complaint for use in food contact applications according to **FDA Regulations** based on clearances granted by FCN 000083 of September 23, 2000, as well as, if applicable, further specific FDA regulations for additives or colorants contained (e.g. FDA 21 CFR 178.3297 Colorants for polymers). Clearance of FCN 000083 permits the base resin Polyphenylsulfone to be used in repeat use food contact applications with all food types, under FDA conditions of use B through H as described in Tables 1 and 2 of 21 CFR 176.170(c).

Compliance with these requirements was not checked on the semi-finished product, as these generally relate to the final article. It is, however, the responsibility of the customer to determine that all conditions and specifications outlined in FCN 000083 are met, and that the products fabricated from these materials are acceptable to the FDA for use in their intended food-contact applications.

Compliance with the extractive limit can only be demonstrated by tests carried out on the final article. The exact provisions can be found at:
